No adjustment of E.M.D. from one work, to another will be entertained. Bidders desirous to hire machineries or equipments from outside the State are required to furnish 2% of the amount put to tender as Bid security.

- 7. Bids shall be received only "on line" on or before 05.00 P.M of 26.05.2022.
- Bids received on line shall be opened at 11.00 A.M. on 02.06.2022 in the office of the Executive Officer, Choudwar Municipality, Choudwar in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- After the date & time of receipt of bid is over, the original financial instruments towards Bid security and Demand draft towards cost of Bid documents shall be submitted in the office of the undersigned between 07.00 A.M of 27.05.2022 to 01.06.2022 up to 1.00 P.M., through Registered/Speed Post failing which the bid will be rejected.
- 10. The SC, ST and Engineer contractors willing to avail the Exemption of E.M.D & 10% preference for SC & ST Contractors will submit the scan copy of affidavit to avail the exemption & preference along with bid documents and the original affidavit, original registration certificate shall be submitted in the office of the undersigned between 07.00 A.M of 27.05.2022 to 01.06. 2 0 2 2 u p to 1.00 P.M. for recording necessary entry for exemption of EMD failing which the bid shall be rejected.
- 11. Name of the work must be mentioned in the affidavit for avail the exemption & preference in individual, work.
- 12. The original documents of scan copies furnished in e-tendering process by the bidder shall be submitted by between 07.00 A.M. of 27.05.2022 to 01.06.2022 up to 1.00 P.M. for verification so-motto failing which the tender will be considered as Non responsive.
- 13. Other details can be seen in the bidding documents.
- The authority reserves the right to cancel any or all bids without assigning any reason.
- 15. If any bidder Uploaded the Bid Document in the Online, but not produced the Original documents for Verification & not submitted the original Paper Cost, he/she will not be entertained in the other tender for three years and also the Paper Cost must be recovered from any other bill.
- 16. Work order will be issued on availability of Funds.
- Additional Performance Security Deposit shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, the bidders who have quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the following rate of additional performance security in shape Bank Draft, Term deposit receipt of Schedule Bank / Kissan Vikash Patra / Post Office Savings Bank Account / National Savings Certificate / Post Office Time Deposit duly pledged in favour of the Executive Officer, Choudwar Municipality, Choudwar of the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security after selected as 1st Lowest Tenderer.

The SC/ST & Engineer Contractors have to deposit the APSD at the time of submission of tender for the less quoted rate. If the SC/ST contractor wants to avail the price preference of 10%, then he has to deposit the balance amount of APSD basing on the amount quoted by the 1st lowest valid tenderer within 7 days from the date of opening of the tender failing which no claim will be entertained for availing price preference and work will be awarded as per codal procedure.

- 19. The single Tender received shall be cancelled without opening of the bid. Defect liability period for CC /interlocking pever road/ CC drain- 3 years. The responsibility will be fixed to the contractor/ Bidder.
- 20. The contractors are required to pay the Royality as fixed by the Government and amended if any from time to time.
- 21. After verifying the site bidder should submit the quoted price in bid document and one affidavit is to be submitted by bidders for each work.
