Sealed quotations are invited from Interested reputed Travel Agencies/Tour Operators/Private Individuals for providing one nos. of AC Petrol/Diesel driven vehicles, having sitting capacity not more than 07 which shall confirm to the Terms and conditions (Appendix-A) for official use in Choudwar Municipality Office on monthly rent basis:

- The service provider shall have a valid OGST registration to participate in 1. the tendering.
- The service provider, participating in the bidding process under the 2. jurisdiction of Municipal Corporations, shall be registered on GeM platform.
- The vehicle must be in road worthy condition, shall not be more than 24 3. (Twenty for) months old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc., mandatory for plying of vehicle.
- 4. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
- 5. The Driver should be well behaved, gentle and obedient in nature.
- A sum of Rs.10,000/- shall be deposited by the intending bidders in shape 6. of Account Payee Bank Draft/Deposit the Cash through the Cashier drawn in favour of the Executive Officer, Choudwar Municipality and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
